ORDER:

In the G.O. first read above, Government have constituted a Selection Committee under the Chairmanship of Justice Sri G, Radhakrishna Rao, retired judge, High Court of Andhra Pradesh with nine members to process the applications received from interested parties for establishment of the Para Medical Institutions and submit recommendations to the Government from time to time for taking necessary action.

2. Based on the norms prescribed by N.T.R. University of Health Sciences, Andhra Pradesh Nursing Council, and Government for establishment of Nursing Schools and Nursing Colleges, Bachelor of Physiotherapy Colleges, B.Sc (MLT) and Para Medical Courses, certain proformae have been prescribed so that the standards /norms prescribed could be verified / could be prescribed by authorities concerned, in the best interest of maintenance of proper standards in each Institution. In the Government D.O. letter second read above, the matter has been referred to the Chairman, Selection Committee for Para Medical Institutions and the Registrar, N.T.R. University of Health Sciences/Director of Medical Education / Indian Nursing Council, New Delhi/A.P. Nursing and Midwives Council for their suggestions.

3. In the letter third and fourth read above, the Chairman Selection Committee for Para Medical Institutions and the Registrar, N.T.R. University of Health Sciences have furnished their suggestions in the matter.

4. Government after examination of the matter have accepted the suggestions of the Chairman, Selection Committee for Para Medical Institutions and the Registrar, N.T.R. University of Health Sciences. Accordingly, Government hereby approve the five Annexures i.e., Annexure-I for Nursing Schools, Annexure-II for Nursing Colleges, Annexure -III for BPT Colleges, Annexure -IV for B.Sc, (MLT) Colleges and Annexure -V for Para Medical Courses and the same are enclosed to this G.O.

4. The Chairman, Selection Committee for Para Medical Institutions, Registrar, N.T.R

University of Health Sciences, Andhra Pradesh Nursing and Midwives Council and Director of Medical Education shall hereafter adhere to the following:-

- They send the detailed information in the said Annexures while sending their recommendations to Government for according permission for establishment of those courses together with their reports.
- Where certain facilities / staff norms etc., need to be provided or adhered to by the institution, the authority concerned shall indicate a reasonable time frame by which the institution should position / provide the facilities.
- Any failure on the part of the Institution to provide the minimum prescribed standards should entail prompt and stringent action .
- the authorities and all concerned should appreciate that maintenance of best possible standards and conduct of courses, examinations etc. will be in the interest of students of Andhra Pradesh and improve their employability within and outside the country.
