ORDER:

In the G.O.Ms No.304 H.M & FW(K2) Department, dated 07-08-1997 rules have been issued on Andhra Pradesh Private Para Medical Training Institutions (Grant of permission and Regulation of admissions into Private Institutions ) Rules, 1997. The Government after careful consideration have decided to issue amendments to the preamble to the said order and the said rules prescribing the Registration fee, renewal fee etc., to the said rules.

2. In the preamble, the orders issued in G.O.Ms.No.304, H.M.& F.W.(K2) Department dated 07-08-1997, in the list of Para Medical Courses after item "IX, Respiratory Therapy" the following shall be added, namely ,-

"X, Multipurpose Health Worker (Male ) Course.

(1). Diploma in Multipurpose Health Assistant ( Male) Course.

### NOTIFICATION

In exercise of the powers conferred by section 99 of the Andhra Pradesh Education Act, 1982 (Act 1 of 1982), the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Private Para Medical Training Institutions (Grant of permission and Regulation of admissions into Private Institutions) Rules, 1997 issued in G.O.Ms.No.304, HM&FW (K2) Department dated 7<sup>th</sup> August, 1997 and as amended from time to time.

### AMENDMENTS

1. In the said Rules, after sub-rule (3) of rule 10 the following shall be added, namely,-

“4 (i) Since the Selection Committee for Para medical Institutions is inspecting the proposed private institutions before sending recommendation to Government for issue of Essentiality Certificate, and since the payment of security deposit by the Institution in the joint account with the Director of Medical Education, Andhra Pradesh, Hyderabad has been dispensed with, the further procedure of forwarding the report by the Director of Medical Education on payment of security deposit by private institutions is dispensed with. The Selection Committee shall have the proposed private institutions inspected and forward the recommendations to Government along with detailed information in the proformae prescribed by the Government.

(ii) On receipt of the recommendations of the Selection Committee for issue of Essentiality Certificate to the concerned Private Para Medical Institutions and also on receipt of intimation from Government, the Institution concerned shall pay the annual Registration fee, as prescribed, to the Commissioner Andhra Pradesh Vaidya Vidhana Parishad, Andhra Pradesh, Hyderabad. The Commissioner Andhra Pradesh Vaidya Vidhana Parishad shall furnish the details of payment of Registration fee by the proposed Private Institutions to Government within a week.

- (iii) Based on the recommendations of Selection Committee- Paramedical Institutions and on receipt of report on payment of Registration fee from the Commissioner, Andhra Pradesh, Vaidya Vidhana Parishad, Andhra Pradesh, Hyderabad, Government shall issue orders according permission to the Private Institution to start the course stipulating such conditions as deemed necessary.
- (iv) The proposed Para Medical Institution shall fulfill all the conditions as prescribed by the Government in the final orders issued, before establishing the institution within a period of one year from the date of issue of orders of Government. In case, the Educational Society fails to fulfill the conditions or fails to start the course within a period of one year, the permission will be cancelled.
- (v) The Director of Medical Education or any other officer deputed by him/ her shall take up regular inspections of the institutions and any no fulfillment of conditions shall entail cancellation of recognition by the Director of Medical Education after giving an opportunity to the concerned Private Institution.
- (vi)(a) In respect of B.Sc (Medical Lab Technology) Degree course, Government will issue necessary orders to the proposed private Institution for establishment of B.Sc.( Medical Lab Technology) course imposing the condition that the proposed Private Institution concerned shall obtain affiliation duly fulfilling the conditions stipulated by the N.T.R. University of Health Sciences, Vijayawada and payment of affiliation fee to N.T.R. University of Health Sciences. The proposed Private Institution shall fulfill all the conditions within a period of six months from the date of issue of Government orders.
- (b) N.T.R. University of Health Sciences shall communicate the final decision of acceptance or rejection as the case may be to the proposed Private Institution within a period of three months from the date of issue of Government orders, under intimation to Government”

(2) For rule 13, the following shall be substituted, namely:-

“ 13.(i) **Annual Registration fee:** - There shall be an annual Registration fee to be paid by those Private Institutions which are issued the Essentiality certificate. The annual Registration fee by way of Demand Draft drawn in favour of the Commissioner, Andhra Pradesh Vaidya Vidhana Parishad, Andhra Pradesh, Hyderabad shall be paid to the Commissioner Andhra Pradesh Vaidya Vidhana Parishad, Andhra Pradesh, Hyderabad, as specified below:-

(ii). After receipt of Registration fee as mentioned in sub-rule (i) above, the Commissioner, Andhra Pradesh Vaidya Vidhana Parishad, Andhra Pradesh, Hyderabad, shall remit the amount in a separate account maintained by him for this purpose. The amount so collected shall later be handed over to the Andhra Pradesh Para Medical Council, Hyderabad as and when it is constituted. The Director of Medical Education shall watch the payment of Registration fee by making necessary arrangements with the Commissioner, Andhra Pradesh Vaidya Vidhana Parishad, Andhra Pradesh, Hyderabad.

(iii). After the first payment as mentioned in sub-rule (i) above, the Commissioner Andhra Pradesh Vaidya Vidhana Parishad, Andhra Pradesh, Hyderabad shall furnish details of payment of Registration fee by the proposed Private Institutions to Government for issue of necessary orders for according permission for establishing the institution and starting the course .

(iv) In respect of proposed Private Nursing Colleges , B.Sc, (Medical Lab Technology) Colleges, Bachelor of Physiotherapy Colleges, there shall be an affiliation fee which shall be paid by the said proposed Colleges to the N.T.R. University of Health Sciences, Vijayawada for every year as prescribed by N.T.R University of Health Sciences, Vijayawada, and they shall fulfill statutory conditions stipulated by the N.T.R. University of Health Sciences, Vijayawada from time to time.

- (v) There shall be a renewal of recognition of the Private Institutions for every five years, subject to satisfactory functioning of the Institution. The renewal fee for all the Private Institutions shall be Rs. 1000/- (Rupees one thousand only) or as may be ordered by Government from time to time for all the above categories of institutions. The Renewal fees in addition to the annual registration fee, shall be paid to the Commissioner Andhra Pradesh Vaidya Vidhana Parishad, Andhra Pradesh, Hyderabad.
