For the above irregularities show cause notice was issued to M/s.Vijaya Institute of Paramedical Sciences, Kurnool vide this office reference 2<sup>nd</sup> cited to submit the explanation for taking further course of action.

So far, the Management has not submitted any explanation to the show cause notice within stipulated time.
