The attention of all Special Chief Secretaries /Principal Secretaries / Secretaries Heads of Departments /Affiliating Authorities/Joint Directors/Deputy Directors of Welfare Departments/Principals of the Educational Institutions in the State and the District Collectors & Chairman of the District Level Committee is invited to the references cited.

2. In the reference 1st & 2nd cited, Government have issued certain guidelines on integrated delivery of services relating to Education and Scholarships under JnanaBhumi and have also issued timelines for completion of key metrics, i.e., Registration and approvals of Colleges, Academic Calendar, Students Admissions (Renewal and Fresh), Fee Structure (General a Variable), Student onetime Bio-Metric Authentication, etc.

3. As per the guidelines, the attendance of the Students of the Colleges should be marked and approved by the respective Principals by 5th of every succeeding month without fail. If it is not done, the Student may be deprived of his MTF and then RTF for that month, which is a very serious lapse on the part of Principals. During the previous State Level Committee Meetings also, it was discussed and the date of the closure of the attendance of the Students is relaxed for June, July & August, considering the requests of the affiliating authorities.

4. The 8th State Level Committee Meeting on JnanaBhumi was held on 30.08.2018 with the Members of the State Level Committee, HODs of Welfare Depts., Affiliating Authorities/Registrar, CDC Deans, Controller of Examinations and Representatives of College Associations and a detailed review of the implementation was held.

5. During the said meeting, the same was discussed in the State Level Committing Meeting with all the participants and it is decided to strictly implement the last date for closure of attendance of Students without any deviations.

6. After detailed discussions and with the consent of all the Affiliating Authorities and Stakeholders, 7th October, 2018 has been fixed as last date for closure of Attendance of the students for the months of June, July, August and September and no further extension of time will be allowed. Hence, it is requested to complete the task before 7th October, 2018, otherwise the Principals concerned are wholly responsible for non-sanction of scholarships to the eligible students and liable for subsequent consequences including the debarring of the said College from the scheme of Post Matric Scholarships.
